GREETINGS

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of the Turners Falls Fire District legally qualified to vote in said District Meeting, to meet at the **Montague Public Safety Building Community Room, 180 Turnpike Road**, Turners Falls on Tuesday, September 16, 2014 at 7:00 P.M. then and there to transact the following business:

ARTICLE 1. To see if the District will vote to authorize the Prudential Committee to petition the General Court for special legislation permitting the District to act in the same manner as a town with respect to the provisions of G.L. c. 44, sec. 53F1/2 for the establishment of enterprise funds, with respect to the provisions of G.L. c. 44, sec. 53E1/2 for the establishment of revolving funds, and with respect to the provisions of G.L. c. 40, sec. 5F for the operation of an ambulance service within the District; subject to all of the requirements of said statutes as applicable to towns thereunder; notwithstanding the provisions of said statutes limiting applicability thereof to cities and towns, and notwithstanding the provisions of any general or special law to the contrary; provided that the General Court may make clerical or editorial changes of form only to the bill, unless the Prudential Committee approves amendments to the bill before enactment by the General Court, and that the Prudential Committee be authorized to approve amendments which shall be within the scope of the general public objectives of the petition; or take any action relative thereto.

And you are hereby directed to serve this Warrant by causing attested copies thereof to be posted in not less than five (5) public places within the District, at least fourteen (14) days before the time of said meeting.

Whereof fail not, and make due the return of the Warrant to the Prudential Committee and Water Commissioners at time of said meeting.
